

CROSSVISION PLUS

"CROSSVISION PLUS" is a physiological pH sterile solution for ophthalmic use containing cross-linked hyaluronic acid and distilled waters of chamomile and mallow.

Cross-linked hyaluronic acid, made using patented technology, preserves all the properties of linear hyaluronic acid while having structural characteristics that give greater stability and longer corneo-conjunctival permanency than its predecessor, as it is degraded more slowly by hyaluronidase enzyme.

The cross-linked structure of hyaluronic acid ensures better hydration and stabilises the tear film. Cross-linked hyaluronic acid gives the product lubricating and hydrating properties. It is therefore recommended for treating dry eyes.

"CROSSVISION PLUS" also contains: [distilled waters of Chamomile and Mallow to ensure moisturising action](#), [sodium Chloride and phosphate buffer to ensure a physiological solution](#).

This formula has been developed to give maximum comfort from the first application. It is recommended for everyday use, day or night.

"CROSSVISION PLUS" is compatible with soft contact lenses.

INTENDED USE

"CROSSVISION PLUS" is recommended for:

- Restoring and improving tear film stability in case of dry eye disease.
- Soothing eye redness, dryness and discomfort caused by:
 - Environmental factors (air conditioning, excessive exposure to sunlight, wind, smoke, pollution, sea or swimming pool water and sea air);
 - Eye strain caused by: studying, prolonged computer use;
 - Abnormal lacrimation following inflammation;
 - Abnormal lacrimation following eye surgery;
 - Use of soft or semi-rigid contact lenses;
 - Refractive surgery.

COMPOSITION

Cross-linked Sodium Hyaluronate aqueous solution (of which 0.3% cross-linked sodium hyaluronate), distilled water of Chamomile, distilled water of Mallow, sodium phosphate dibasic

dodecahydrate, sodium phosphate monobasic monohydrate, sodium chloride, water for injections. Contains no preservatives.

INSTRUCTION FOR USE

- Wash and dry your hands thoroughly before use;
- Detach the single-dose from the strip and twist off the cap. Do not throw away the cap, it will be used to re-close the single dose;
- Place the cap taking care to put it on a clean surface;
- Gently squeeze 2 drops into each eye;
- Close the single-dose immediately after use: the contents may be reused within 12 hours of first opening.

WARNINGS AND PRECAUTIONS

- If you suffer from severe damage to the clear layer at the front of the eye (the cornea), phosphates may cause in very rare cases cloudy patches on the cornea due to calcium build-up during treatment;
- Strictly personal use only;
- Ophthalmic use only;
- Do not use the product if the single-dose container is damaged or unsealed when first purchased;
- Do not use if are visible particles and/or changes in the color of the solution;
- During application, do not touch the eye or any other surface with the tip of the single-dose;
- Do not use in case of known incompatibility towards any of the components of the solution and/or Asteraceae plants and/or Malvaceae plants;
- The product is not suitable for children;
- If side effects occur during use, stop using the product and consult a doctor;
- No interactions with drugs or other eye drops are reported; however, leave at least 15 minutes between administrations of any other eye drops;
- Do not use the product after the expiry date shown on the pack and on the single-dose;
- Dispose of the [product](#) according to your local waste management regulations;
- Keep out of reach of children;
- Consult your doctor before you use this product if you are pregnant or breast-feeding;
- For external use, do not swallow;
- It is necessary to report any serious incident occurred in relation to the device to the manufacturer and the Competent authority of the Member state in which you are established.

SIDE EFFECTS

Immediately after application, the vision may be slightly impaired for a short time. It is therefore advisable to wait for a few seconds before any activity that requires clear vision.

STORAGE CONDITIONS

Keep the product dry between 2°C and 30°C and away from direct heat and sunlight.

The single-dose contents may be used within 12 hours of first opening.

PACKAGING

From 5 to 30 re-closable single dose of 0.5 ml.

VALIDITY

If unopened, do not use the product after the expiry date shown on the pack and on the single-dose container.
